Your privacy is important to us at Brookdale Church. The information we collect will be treated in accordance with the UK Data Protection Act 2018. The information given in section 1 is required to enable us to run the youth club safely. The information will be held in paper form securely locked on the church premises. Email addresses and phone numbers may be stored in a club owned phone, which is kept locked on church premises. It will only be made available to the leaders of Sparklers Club and the leadership team of Brookdale Evangelical church for the purpose of running Sparklers Club. In an emergency the medical information may be made available to medical professionals. We will not share any information with any third parties unless the law requires us to do so. The information in section 1 will only be retained for the academic year 2019-2020, it will be destroyed in September 2020 and new information will be sought for the next academic year. Section 2 will be retained for as long as we retain any images or video files. You have the right to request access to your personal data we hold and request that we delete any information we hold.
